This Privacy Policy of the website https://www.mina.am/ (the "Policy") applies to all information that AM Restaurants 374 (the Restaurant) may receive about the user during their use of the Website, and the services provided by the Restaurant using the Website.

1. Terms and definitions

- 1.1. "Restaurant" AM Restaurants 374 is a legal entity, as well as partners
- 1.1.2 "Personal Data", "Personal Information" any information relating directly or indirectly to a defined or identifiable individual (the subject of the Personal Data)
- 1.1.3. "Processing of Personal Data" any action (operation) or set of actions (operations) performed with or without the use of automation tools, including, systematization, accumulation, storage, clarification (update, change), extraction, use, transfer (distribution, blocking, removal, destruction of Personal Data.
- 1.1.4 "Confidentiality of Personal Data" a mandatory requirement of the Restaurant or other person having access to Personal Data not to allow their dissemination without the consent of the subject of Personal Data or availability of other legal grounds
- 1.1.5 "Partners of the Restaurant" legal entities or individuals counterparties of the Restaurant.
- 1.1.6. "Site User (hereinafter "User")" The person, who has access to the Site through information and telecommunication network of Internet and uses the Site.
- 1.1.7. "Cookies" is a small fragment of data, sent by a web-server and stored on a user's computer, which a web-client or a web-browser sends to a web-server in an HTTP-request each time it tries to open a page of the corresponding site.
- 1.1.8. "IP-address" the unique network address of a node on an IP-based computer network.
- 2. Personal data includes all information or data that identifies an individual or can be used to identify an individual, including:
- Last name, first name, middle name of the user;
- Date of birth of the user;
- User's contact phone number;
- E-mail address (E-MAIL);
- Residence address (in case if the User uses a delivery service);.

Personal information includes any information obtained by the Restaurant in connection with the use of the Website and Services of the Restaurant, including information about the User's device, IP address.

The Restaurant does not verify the accuracy of the personal information provided by Users, but the Restaurant assumes the integrity of Users.

The Restaurant has the right to collect and analyze information about the IP addresses of its visitors.

Data, such as telephone number and e-mail address, are not personal data of the User, if the processing of this data is performed impersonally, i.e. without referring to the personal data of the particular User, their order history in the Restaurant.

- 3. The Restaurant may collect general, aggregated, demographic, and non-personal information from you. It may be linked to your personal information, through cookies or other means. This type of anonymous, aggregated profiling and session data may include information that you have provided to us through surveys, polls, etc. We may also collect information about you to optimize our site or diagnose problems with the site. This information is often used in aggregate to see trends, but may also be connected to your personal account information.
- 4. Filling in the fields of the forms containing personal information in the sections "Book a table", "Contacts", "Feedback", "Delivery" means that the User voluntarily submitted their personal information to the RESTAURANT AM Restaurants 374 for further processing for the purposes specified in this Policy.

By providing her/his personal data, the User entitles the Restaurant to perform the following actions (operations) with personal data: collection and accumulation, systematization, storage for the period of reporting established by the regulatory documents, but not less than three years, from the date of the termination of the use of services by the User, specification (update, change), use, distribution (including the transfer on the territory of the Republic of Armenia and cross-border transfer), depersonalization, blocking, destruction of personal data.

By using the Site, the User consents to the collection, processing and storage and distribution of their personal data and information, within the framework provided by them in connection with the use of the Site and the services of the Restaurant.

If you do not agree to these terms and conditions, you must refrain from using the Site.

4. The RESTAURANT may use personal data and personal information solely for the following purposes:

- Providing personalized services to the user;
- Communication with the user, including sending notifications, requests and information regarding the use of the services, the provision of services, as well as processing requests and applications from the user
- Improving the quality of the application, its usability, development of new services and services:
- Conducting statistical and other research based on anonymized data
- Advertising of products and services
- Other purposes not inconsistent with applicable law.

5. The restaurant stores personal data in accordance with this Policy and the requirements of legislation on the protection of personal data. The User's personal data will be processed without limitation of time and in any lawful manner, including in information systems of personal data with or without the use of automatic means.

The User agrees that the Restaurant may transfer personal data to third parties, in particular, courier services, postal organizations, telecommunications operators, in order to fulfill the user's order, the partners of the Restaurant, with which it has concluded an agreement on the joint use of this site, as well as to inform and attract the attention of the user about the conditions of services, including promotions.

In case of loss or disclosure of personal data, the Restaurant will inform the user about the loss or disclosure of personal data.

Except as discussed in this Policy, the Restaurant will not sell, rent, or otherwise use your personal information for a commercial purpose unless prior approved by user.

6.The use of the Restaurant's website constitutes the user's unconditional agreement to this Policy. If the User does not agree to these terms and conditions, the User should refrain from using the Restaurant's Services.

The User's consent to the processing of his or her personal data is valid from the day of initial use of the Restaurant's website until the day of withdrawal of consent, by contacting the representatives of the Restaurant in the manner set forth in this Policy.

The Restaurant undertakes the necessary organizational and technical measures to protect personal data.

The personal data of the persons from European Union is protected according to terms of General Data Protection Regulation (GDPR).

The information relating to personal data of customers (buyers) and other persons which has become known in connection with the implementation of the organization of its activities, and its employees of their official (functional, professional) duties, is confidential and protected by law.

Employees and other persons who have access to processed personal information are aware of the list of regulations governing the procedure and rules of data processing and are aware of the possible disciplinary, administrative, civil or criminal liability in case of their violation.
